Notice is hereby given that City of Greenfield, Indiana, Economic Development Commission will conduct a public hearing on June 9, 2025, at 3:00 p.m., local time, at the Richard J. Pasco Council Chambers, Room 127, located in the Keith McClarnon Government Center, 10 South State Street, Greenfield, Indiana 46140, concerning the proposed financing of certain economic development facilities by the City of Greenfield, Indiana (the "City"), consisting of a downtown parking garage (the "Project"), by TRG Development, LLC. The Project will be partially financed through a Financing Agreement related to the City of Greenfield, Indiana, Economic Development Revenue Bonds, Series 2025 (the "Bonds").

The Bonds will not be an indebtedness or general obligation of the City. The principal of the Bonds and the interest payable thereon will be payable solely from funds legally available and appropriated by the City for such purposes, which may include certain tax increment revenues received by the Greenfield Redevelopment Commission from the allocation area in which the Project is located, all as described in the Bond Ordinance of the City Common Council (the "Bond Ordinance") and bond documents of the City with respect to the Bonds and the Project.
